SAMOYED CLUB OF VICTORIA INC RESPONSIBLE BREEDER CODE OF PRACTICE

Each member, upon being admitted or re-admitted to inclusion of the Samoyed Club of Victoria Inc (herein after 'The Club') Responsible Breeder listing shall be bound by the following Code of Practice.

You MUST

- Be a financial member of The Samoyed Club of Victoria Inc
- Be a financial member of a recognised State Kennel Controlling Body of the state you reside in.
- Must have a registered breeder's prefix recognised by the State Kennel Controlling Body of the state you reside in.
- All members of the prefix must be financial and will all be held equally responsible
- Adhere to the Club Code of Ethics, your State Controlling Body and the Dogs Australia Code of Ethics. (Dogs Victoria Code 20.1 Code of Practice)
- Breed to the requirements set down by The Club relating to health testing Hips, Elbows, Eye Testing (Gonioscopy). (Which will be reviewed and updated if required on a regular basis)
- Only breed with a Dogs Australia registered Samoyed male that has all the health checks mandated by The Club. (Hips, Elbows, Eye Testing (Gonioscopy) (Exceptions being semen collected and frozen prior to 1/1/2020. Semen imported from overseas. (Excluding N.Z.))
- Only breed with a Dogs Australia registered Samoyed female that has had all health checks (Hips, Elbows, Eye Testing (Gonioscopy)) mandated by The Club and has reached adequate maturity age of 18months. (Dogs Victoria minimum breeding age)
- All puppies whelped must be registered with Dogs Victoria or a recognised State Controlling Body in the state that you reside in.
- Supply new owners with:
 - o Dogs Australia Registration certificates either full or limit register
 - o Contract of Sale
 - Vaccination certificate
 - o The Club Puppy Booklet
 - All Health Records of Sire, Dam & Puppy (Hips, Elbows, Eye Testing (Gonioscopy))
 - o DEDJTR Breeders Source Number (if applicable)
 - o Dogs Victoria Membership Number
 - o Samoyed Club of Victoria Inc Responsible Breeder Scheme Member Number
- Advise The Club of the following within 3 months of whelping
 - o Dogs Australia Registration Name
 - O Dogs Australia Registration number
 - Date of birth
 - o Sex
 - o Sire
 - o Dam
 - o Microchip number
 - New owner name
 - o DEDJTR Breeders Source Number (if applicable)
- Must maintain the following records and supply copies to puppy purchasers or The Club if requested in relation to a dispute:
 - o Dogs Australia registration papers (breeders' copy)
 - Contracts of Sale
 - Service contracts
 - Breeding records
 - Vaccinations
 - o Health certificates of Sire & Dam
 - Veterinary reports (if applicable)

DISPUTE RESOLUTION

An approved Responsible Breeder agrees that any disputes pertaining to breeding, sale of puppies, health issues, monies paid or received, disputed ownership or lease agreements will, with the agreement of all parties be mediated by an independent arbiter appointed by The Club and agrees to abide by the arbiters ruling. Excluding all matters referred to any Dogs Australia State Controlling Body.

Any expenses incurred by the Club in dealing with a breach may be imposed on the breeder as a penalty if found to be in breach of the rules. All penalties either financial and or suspension/ cancellation must be finalised before reinstatement can be applied for.

An approved Responsible Breeder found to be in breach of any breeding or misconduct rules relating to sales of puppies by any Dogs Australia State Controlling Body will have their Responsible Breeder status revoked and the member will not be permitted to use the wording "Samoyed Club of Victoria Inc Responsible Breeder" or any reference to the Samoyed Club of Victoria Inc in their advertising or in the promotion of their kennel as well as any other sanction The Club sees fit to impose.

Should the State Controlling Body impose a suspension/cancellation of that membership due to <u>any</u> disciplinary matter, their Responsible Breeder status and The Club membership will also be suspended or cancelled.

An application can be made to The Club for reinstatement of their Responsible Breeder status once all matters have been finalised with the State Controlling Body.

The Club retains the right to refuse membership to the Responsible Breeder scheme.

APPROVAL

Upon signing an application applying for admission to the 'Samoyed Club of Victoria Inc Responsible Breeder Scheme' which states that you agree to abide by the rules and conditions, the application will be presented to the committee of The Club, at a committee meeting or special general meeting of The Club for approval.

Once approved and on payment of an annual fee (\$25) a breeder will be forwarded a numbered certificate which will authorise the use of the phrase "Samoyed Club of Victoria Inc Responsible Breeder" Member No. 3000000000 which must be used in their advertising.

The fee to be set will be reviewed annually, this fee is to be kept in a separate account and used for administration of the Samoyed Club of Victoria Inc Responsible Breeder Scheme.
